These matters are before the court on the EPA's renewed motion to dismiss or transfer, to reconsider referral of the jurisdictional issues presented to the merits panel, and to stay briefing on the merits. The EPA also requests en extension of time, as well as an increase in the word count, in the event briefing proceeds in this court. We also have responses to the motion, as well as a reply from the EPA.

In short, we have determined transfer to the District of Columbia Circuit is warranted. To that extent, the EPA's motion is granted. Accordingly, we vacate our order dated April 18, 2011. The clerk is directed to transfer all of these matters to the D.C. Circuit, and in that regard is directed to transfer all relevant materials and information. In light of this disposition, all other requested relief is denied as unnecessary, including the pending motion to extend the respondent's briefing deadline to September 7, 2011. A copy of this order shall stand as the mandate of this court.
