### **The Latest News**

- U.S. COVID-19 cases exceed 1,329,225 and 79,525 U.S. deaths. (Source: CDC) (Updated 5/11/20)
- **U.S. stock market**: On Friday the major U.S. benchmarks all posted gains, with the Dow rising 455 points, the S&P 500 up 48 points, and the Nasdaq gaining 141 points. Weekend trading in stock futures were effectively flat as of Sunday night. (New)
- The Department of Labor's employment <u>report</u> last Friday showed that **the health care industry lost more than 1.4 million jobs**. While no sector has been immune from significant job losses, the health care sector impact is especially complex since hospitals and other providers were required to ramp up emergency, ICU, and testing capabilities in preparation for the surge in

- coronavirus cases which was predicted, but elective procedures were suspended resulting in layoffs in nearly all types of outpatient and clinic settings. (New)
- <u>Data</u> from the Epic Health Research Network shows that preventive cancer screenings have dropped 86-94% due to suspension of elective procedures and access disruptions during the emergency response to COVID-19. The data was collected from 2.7 million patient records in 39 states. (New)
- The challenges of reopening were felt at the government's highest levels late last week when two senior officials in the White House were confirmed to have COVID-19 resulting in the self-quarantine by the NIH Institute of Allergy and Infectious Disease Director Anthony Fauci, White House Coordinator of Coronavirus Response Deborah Birx, and CDC Director Robert Redfield. In separate incidents FDA Commissioner Stephen Hahn announced he was in self-quarantine due to exposure to an unnamed individual and Tennessee Senator Lamar Alexander was in self-quarantine following the confirmation that his chief of staff had COVID-19. (New)

### **COVID-19 Federal Legislation**

- Bill 4.0: House Democrats had planned to release their proposals for the 4.0 relief package today but debate within the caucus has delayed their hope for a quick consensus package. House Democratic moderates, especially those in swing districts, have concerns about the expansive size of the leadership's list of priorities and the dollars attached. The challenges for next emergency spending bill also include concerns voiced by some Republicans that the growing deficit needs to be acknowledged the cost of previous four relief bills is a little under \$3 trillion. (New)
  - The Congressional Budget Office released is monthly review with <u>data</u> showing that Medicare spending has nearly tripled. The report also noted that normally April is a month when federal revenues are up, but its data shows U.S. budget revenues down by 55%. (New)

- The DHS Transportation Security Administration <u>announced</u> new security measures which include requiring its employees to wear masks while at screening checkpoints. Passengers are already encouraged to wear facial protection but may be asked to pull down the mask for identification purposes. (5/7/20)
- FEMA and HHS jointly released a <u>video</u> on how the agencies collect critical data, analyze the data, and communicate the findings to appropriately distribute supplies. (5/7/20)
- FEMA issued a fact sheet describing the **federal support being provided to expand national testing capabilities.** (5/5/20)
- FEMA <u>announced</u> \$200 million in supplemental funding under the CARES Act for local jurisdictions to help service organizations that provide critical resources. (5/4/20)
- President Trump signed an <u>executive order</u> temporarily "pausing," for period of 60 days, certain U.S. immigration processes. The President noted he would revisit the issue after 60 days and depending on the economy may choose to extend the suspension. (4/22/20)

## **Department of Justice/Federal Trade Commission/Litigation**

## **Consumer Protection/Anti-fraud**

- The Federal Trade Commission (FTC) <u>sent</u> 45 letters warning marketers nationwide to **stop** making unsubstantiated claims that their products and therapies can treat or prevent COVID-19. This fourth round of letters targeted "treatments" including Chinese herbal medications, music therapy, homeopathic treatments, and even shields claimed to boost the immune system by protecting the wearer from electromagnetic field. There is currently no scientific evidence that these or any services can treat or cure COVID-19. The letters warn that if marketers refuse to stop making false claims, the FTC may seek an injunction and an order requiring money be refunded to consumers. (5/7/20)
- The FTC provided <u>guidance</u> for businesses to **avoid scams** while applying for loans through the SBA's Paycheck Protection Program (PPP) or Economic Injury Disaster Loans (EIDL) program. FTC advises businesses to get information directly from the SBA's website (sba.gov/coronavirus) and not apply for a loan before verifying the lender. If businesses identify scams, they are asked to submit a complaint at ftc.gov/complaint. (4/29/20)

### Litigation Issues

- The Department of Justice <u>announced</u> the **first enforcement action regarding alleged PPP fraud**. The DOJ alleged that two defendants falsely claimed to have dozens of employees at several locations to get more than \$500,000 in forgivable loans. (5/5/20)
- The impact of the coronavirus pandemic may be a scheduling challenge for the courts, but bankruptcy cases remain active. For an examination of the implications of a bankruptcy case



- where the majority shareholder seeks to enforce its blocking rights, read this A&B <u>advisory</u>. (5/8/20) (New)
- Higher education protected students' and employees' health by closing their campuses and moving – virtually overnight – to online learning. #### **Small Business Administration**

- Small Business Administration (SBA) In response to the CARES Act requirements, the SBA formally <u>launched</u> its Paycheck Protection Program (PPP) for small businesses. (4/3/20)
  - o The SBA released PPP of Round 2 data. (5/8/20) (New)
  - The SBA released its latest PPP data that the agency had processed 2.5 million applications from 5,425 lenders for loans totaling \$185.4 billion. The average loan size is a little greater than \$74,000. The posted data also shows that 53% of the loan amount has come from banks with more than \$50 billion in assets, 15% from mid-size banks, and 32% from lenders with less than \$10 billion in assets.   - The SBA and Treasury updated their FAQs on the Paycheck Protection Program. The
     <u>FAQs</u> clarify that employers will not be penalized if they are unable to rehire a worker
     despite good faith efforts. (Updated 5/6/20)
    - The FAQs also **extend the safe harbor to repay PPP loans** until May 14 and confirms that **foreign affiliate employees** must be counted for size purposes.

- The Treasury <u>announced</u> plans to increase the amount of debt the Department will issue in quarterly **refunding auctions to a record high of \$96 billion**. - Treasury and the Department of the Interior <u>announced</u> an agreement to begin making \$4.8 billion in funds available to Tribal governments under the CARES Act. (5/5/20)
- The Federal Reserve <u>announced</u> that it was <u>modifying</u> its **liquidity coverage ratio for banks** participating in the Money Market Mutual Fund and Paycheck Protection Program Liquidity Facilities. (5/5/20)
- The Federal Reserve <u>announced</u> an expansion of the scope and eligibility for the Main Street Lending Program, essentially creating a third option to help credit flow to small and mediumsized businesses. (4/30/20)

- FHFA announced that Fannie Mae and Freddie Mac created **online property lookup tools** to allow renters to see if they live in a property that is covered by the temporary eviction moratorium. (5/4/20)
- The **U.S. Patent and Trademark Office** announced (4/28/20) that it would further extend certain <u>patent</u> and <u>trademark</u> deadlines to June 1, 2020, given the ongoing effects of the COVID-19 pandemic. These extended deadlines apply to those situations identified in the USPTO's March 31, 2020, guidance, such as responses to Office Actions.

   COVID-19, says USTR. China is expected to fully meet its obligations under the U.S.-China phase one trade agreement "in a timely manner" despite the novel coronavirus outbreak that has
   wreaked havoc on the global economy, U.S. Trade Representative Robert Lighthizer and
   Treasury Secretary Steven Mnuchin <u>said</u> in a joint statement late Thursday after a phone call
   with their Chinese counterpart. "Both sides agreed that good progress is being made on creating



- the governmental infrastructures necessary to make the agreement a success," the statement said. "They also agreed that in spite of the current global health emergency, both countries fully expect to meet their obligations under the agreement in a timely manner." (New)

- On April 24, the Rutgers Center for Risk and Responsibility and the National Council of Insurance
  Legislators (NCOIL) sponsored a webinar attended by hundreds of legislators, government
  officials, industry professionals and others to discuss state legislative proposals that would
  retroactively require insurers to provide coverage for business income losses caused by
  COVID-19. NCOIL President reportedly "began by expressing NCOIL's opposition to retroactive
  legislation at the state level." A recording of the webinar is available online. (New)
- The pace of new business income coverage claims flooding state and federal courts nationwide has not slowed over the last few weeks. In addition to new case filings, we continue to monitor requests by Plaintiffs to transfer and consolidate federal COVID-19 business interruption cases into an industry-wide MDL notwithstanding significant variations between the policyholders, issuers, terms, coverages claimed, and causes of action alleged. A group of insurance industry trade groups led by the American Property Casualty Insurance Association has filed an Amici Curiae Brief in Tambellini v. Erie Insurance Exchange, urging the Pennsylvania Supreme Court to deny Plaintiff's Emergency Application for Extraordinary Relief, which seeks to bypass the ordinary course trial court procedures and catapult Plaintiff's claims straight to the Pennsylvania Supreme Court under the court's infrequently-used King's Bench Powers. (New)
- Other Notable case filings include:
  - On May 7, Hartford Fire Insurance Company ("Hartford") filed suit against its insured Moda LLC et al ("Moda") in Connecticut state court, seeking a declaration that Hartford has no obligation under Moda's policy to pay claims for Moda's alleged losses of business income due to COVID-19. Hartford's declaratory judgment action follows earlier lawsuits by Moda against Hartford seeking a declaration that Hartford is obligated to pay Moda's claims for business income coverage. The case is Hartford Fire Ins. Co. v. Moda LLC et al., No. HHD-CV20-6127638 (Hartford Sup. Ct., Conn.) (New)
  - Also on May 7, Rinnigade Art Works <u>filed suit</u> against its insurers The Hartford Financial Services Group, Inc., Hartford Fire Insurance Co., and Twin City Fire Insurance in the federal district court for the District of Massachusetts seeking a declaration that Plaintiffs have "suffered direct physical loss of and/or damage to . . . insured premises" resulting in "interruptions or suspensions of business incomes" and that the resulting losses are covered under Plaintiffs' policies. Plaintiffs also seek damages for breach of contract and violation of Massachusetts General Laws, Chapter 93A. Plaintiff seeks to represent a class "of persons and entities located in

Massachusetts and such other states as the Court may deem appropriate." The case is *Rinnigade Art Works, et. al. v. The Hartford Fin. Servs. Grp., Inc., et al.*, No. 1:20-cv-10867-IT (D. Mass.) (New)

- On April 30, the General Assembly of Pennsylvania proposed <u>Senate Bill No. 1127</u> "r]elating to property and business interruption insurance coverage for COVID-19 Pandemic-related Losses." The Bill is structured differently than <u>earlier proposals</u> in that rather than simply asserting that policies will be construed to cover COVID-19 business income losses, it instead applies certain "rules of construction" to first-party insurance policy provisions in order to tie common coverage-triggering terms to COVID-19 related executive orders and the presence of the virus in a particular business.
- The National Association of Insurance Commissioners has issued a <u>Business Interruption COVID-19 Data Call Letter</u> to property and casualty insurers indicating that state insurance regulators in 50 states, the District of Columbia, and the U.S. territories "have agreed to participate in a data call to collect data related to business interruption insurance and COVID-19." Insurers are "requested to complete both parts of the COVID-19 business interruption data call" and to submit a "Premiums Data Template" by May 22, and a "Claims Data Template" by June 15, with mid-monthly update filings thereafter.
