Representative Experience

Appellate Matters

- Received a favorable opinion from the Fort Worth Court of Appeals holding that the client's due process rights were violated when the trial court entered final judgment without sufficient notice.
- Preserved the trial court's holding that a non-party lacked standing to challenge a client's bona-fide-purchaser status in an appeal arising from a foreclosure sale in New York.
- Opposed review by the Texas Supreme Court, preserving an appellate victory for a mineral interest owner in a royalty dispute.
- Obtained victory for a Texas electricity provider on an issue of first impression that required the Texas Supreme Court to interpret a statute that creates a tax exemption for pollution-control equipment.
- Opposed certiorari at the U.S. Supreme Court, after the Court requested responsive briefing, preserving a defense victory for a railroad client in a multibillion-dollar class action.
- Represented the Texas Oil and Gas Association as amicus curiae before the Texas Supreme Court in a case requiring interpretation of critical and customary oil and gas lease language.
- Obtained reversal of the trial court's declaration that an easement was void for a retailer client on appeal to the Houston Court of Appeals (14th Dist.).

- Represented a railroad as an appellate specialist during a two-week jury trial, in which the railroad successfully secured a multimillion-dollar verdict on all contract and tort claims; represented the railroad on appeal until settlement.
