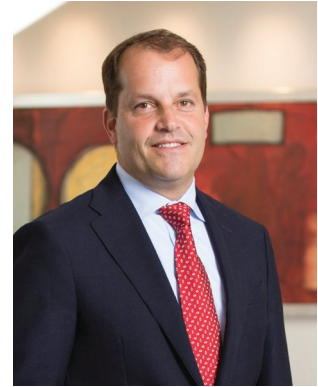

Jeff represents contractors in False Claims Act and internal investigations, claims litigation, and procurement protests, and advises on complex compliance issues.

Jeff is a former Department of Justice (DOJ) trial attorney who is now principal claims and investigations counsel to some of the most successful and sophisticated contractors and vendors in the country. Jeff maintains compliance practices in health care, defense, aerospace, communications, financial services, and infrastructure. Jeff is regularly engaged as special counsel for government contracts in M&A transactions involving federal contractors, and Jeff has even testified as an expert on government contracts before a federal criminal jury.

### **Representative Experience**

- Represented defendants in qui tam (False Claims Act) lawsuits and in responding to civil investigative demands, including suits alleging illegal sales to the federal government of products that do not comply with domestic source restrictions applicable to such sales, violations of the Anti-Kickback Act, and fraudulent pricing and billing schemes.
- Represented government contractors in pre-award and post-award protests at the federal, state, and local levels, including at the Government Accountability Office, U.S. Court of Federal Claims, and tribunals in Georgia, Virginia, Kentucky, North Carolina, Minnesota, Massachusetts, Florida, Louisiana, and California.
