Jonathan Parente is co-leader of Alston & Bird’s national Business Litigation Team. Jonathan’s appellate experience includes representing oil and gas companies before the U.S. Supreme Court in *Dart Cherokee Basin Operating Co. LLC v. Owens*, 135 S. Ct. 547. The decision makes it easier for corporate defendants to remove cases from state court to federal court.

Jonathan joined the firm after serving as a law clerk to the Hon. R. Lanier Anderson III of the U.S. Court of Appeals for the Eleventh Circuit and the Hon. J. Randal Hall of the U.S. District Court for the Southern District of Georgia.
